As you may be aware, intu properties plc and seven other group companies were placed into administration on 26 June 2020. The names of these companies are attached at Appendix 1 (“the Administration Companies”).

Please note that companies which own the Shopping Centres (‘Centres’) listed in Appendix 2, have not entered administration and are continuing to trade as normal under the control of their directors, whilst a buyer(s) for the Centres is found.

Whilst some services and employees are provided to the Centres by some or all of the Administration Companies, the Administration Companies intend to continue to provide these services to the Centres until the site is sold and on the basis that the Propco owners of the Centres have committed to fund these services. Consequently, there should be no adverse effect of the administration appointments on your continued occupation of the Centres.

Please continue to liaise with your usual Intu contacts regarding operations at the Centres and the timely payment of rent and service charges.
